4. First Aid Measures

Personal Precautions

Wear tightly fitting safety goggles which adhere to European standard EN 166. Ensure Hexafluorine eye wash is to hand

8.2.3 Hand Protection

Handle with impermeable gloves. Inspect gloves before use. Gloves must satisfy the specifications of EU Directive 89/686/EEC and the standard EN374 derived from it. Use proper glove removal technique (without touching glove's outer surface) to avoid skin contact with this product.
