4. First Aid Measures**4.1.1 Eye contact**

Where Diphtherine is not available, rinse eyes with copious amounts of water for at least 20 minutes. Protect uninjured eye. Remove contact lenses if present and easy to do. Continue rinsing and seek immediate medical attention.

If swallowed rinse the mouth with plenty of water (only if the person is conscious) and contact a poison centre or physician if you feel unwell.

Remove person to fresh air and keep comfortable for breathing. Call a poison centre or physician if you feel unwell. If breathing is irregular or stopped, administer artificial respiration.
