4. First-aid measures

Inhalation	If breathing is difficult, remove to fresh air and keep at rest in a position comfortable for breathing. Call a physician or poison control center immediately. Induce artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. Do not use mouth-to-mouth method if the substance is inhaled.
Skin contact	Call a physician or poison control center immediately. Remove and isolate contaminated clothing and shoes. Rinse skin with water/shower. Wash contaminated clothing before reuse.
Eye contact	Rinse with water. Get medical attention if irritation develops and persists.
Ingestion	Rinse mouth thoroughly. If ingestion of a large amount does occur, call a poison control center immediately. Do not induce vomiting without advice from poison control center. Do not use mouth-to-mouth method if substance is ingested. If vomiting occurs, keep head low so that stomach content doesn't get into the lungs.

General information	Remove from exposure. Remove contaminated clothing. For treatment advice, seek guidance from an occupational health physician or other licensed health-care provider familiar with workplace chemical exposures. In the United States, the national poison control center phone number is 1-800-222-1222. If person is not breathing, give artificial respiration. If breathing is difficult, give oxygen if available. Persons developing serious hypersensitivity (anaphylactic) reactions must receive immediate medical attention.

7. Handling and storage

Precautions for safe handling

As a general rule, when handling USP materials, avoid all contact and inhalation of dust, mists, and/or vapors associated with the material. Clean equipment and work surfaces with suitable detergent or solvent after use. After removing gloves, wash hands and other exposed skin thoroughly. Select and use containment devices and personal protective equipment based on a risk assessment of material potency and exposure potential.
