### 4. First-aid measures

<b>Inhalation</b>	Move to fresh air. Call a physician if symptoms develop or persist.

Select and use containment devices and personal protective equipment based on a risk assessment of material potency and exposure potential.

### Appropriate engineering controls

Control exposures to below the occupational exposure level (if available). Select and use containment devices and personal protective equipment based on a risk assessment of exposure potential.
