## 7. Handling and storage

An industrial hygiene survey involving air monitoring may be used to determine the effectiveness of engineering controls. Local exhaust ventilation such as a laboratory fume hood or other vented enclosure is recommended, particularly for grinding, crushing, weighing, or other dust-generating procedures.
