4. First-aid measures

Inhalation	If breathing is difficult, remove to fresh air and keep at rest in a position comfortable for breathing. Call a physician if symptoms develop or persist.

NOTE: Even in the conscious patient, cough and gag reflex may be so depressed as to necessitate special protection against aspiration of gastric contents and orally administered materials. Treat convulsions with a short-acting barbiturate given intravenously and carefully titrated for the smallest effective dosage. Provide intensive support of respiration and cardiovascular-renal function for severe intoxication. Do NOT use CNS stimulants.
General information	Remove from exposure. Remove contaminated clothing. 7. Handling and storage

Precautions for safe handling	As a general rule, when handling USP Reference Standards, avoid all contact and inhalation of dust, mists, and/or vapors associated with the material. Clean equipment and work surfaces with suitable detergent or solvent after use. After removing gloves, wash hands and other exposed skin thoroughly. Select and use containment devices and personal protective equipment based on a risk assessment of material potency and exposure potential.
