4. First-aid measures

Monitor vital signs, pulse oximetry, and cardiac function. Monitor for CNS and respiratory depression. For respiratory depression, administer oxygen and assist ventilation. Protect airway with orotracheal intubation. For coma and respiratory depression, reverse with naloxone. Administer intravenously, intramuscularly, intratracheally, intranasally, or subcutaneously. A continuous infusion might be needed for long-acting opioids. For seizures, treat with intravenous benzodiazepines. If seizures persist, administer propofol or barbiturates. For hypotension, treat with an infusion of isotonic fluid. If hypotension persists, administer dopamine or norepinephrine. Hemodialysis and hemoperfusion are not recommended.

General information

Remove from exposure. Remove contaminated clothing.
