Provide general supportive measures and treat symptomatically. When serum calcium concentrations are greater than 12 mg per 100 mL, immediate measures may be required with possible use of the following: Hydrate with intravenous 0.9% sodium chloride injection; forced diuresis with furosemide or ethacrynic acid may rapidly increase calcium and sodium excretion when saline overload occurs. Monitor potassium and magnesium serum concentrations and start replacement early. Monitor ECG and consider the possible use of beta-adrenergic blocking agents to protect the heart against serious arrhythmias. Consider including hemodialysis, calcitonin, and corticosteroids in the treatment. Determine serum calcium concentrations at frequent intervals to guide therapy adjustment.

General information

Remove from exposure. Remove contaminated clothing.
