Hydrate with intravenous 0.9% sodium chloride injection. Force diuresis with furosemide or ethacrynic acid to rapidly increase calcium excretion. Monitor serum potassium and magnesium; start replacement early, if indicated. Monitor ECG; use beta adrenergic blocking agents to protect the heart against arrhymias. Include hemodialysis, calcitonin, and corticosteroids in treatment, if needed. Monitor serum calcium

concentrations frequently to guide therapy adjustments.
