4. First-aid measures

Monitor serum potassium and magnesium; start replacement early, if indicated. Monitor ECG; use beta adrenergic blocking agents to protect the heart against arrhythmias. Include hemodialysis, calcitonin, and corticosteroids in treatment, if needed. Monitor serum calcium concentrations frequently to guide therapy adjustments. [Hazardtext 2010; USP DI 2004]
General information	Remove from exposure. Remove contaminated clothing. For treatment advice, seek guidance from an occupational health physician or other licensed health-care provider familiar with workplace chemical exposures.
