Provide general supportive measures and treat symptomatically. Administer activated charcoal as a slurry. Perform gastric lavage. Place patient in a supine position. For seizures, administer a benzodiazepine intravenously, followed by phenobarbital or propofol if the seizures recur. Monitor for hypotension, dysrhythmias, respiratory depression, and need for endotracheal intubation. Evaluate for hypoglycemia, electrolyte disturbances, hypoxia. Monitor bone marrow toxicity, bleeding tendency, and infection. Septicemia may be a fatal complication. Monitor electrolyte balance.
