### 4. First-aid measures

<b>Inhalation</b>	If breathing is difficult, remove to fresh air and keep at rest in a position comfortable for breathing. Call a physician if symptoms develop or persist.
<b>Skin contact</b>	Rinse skin with water/shower. Get medical attention if irritation develops and persists.
<b>Eye contact</b>	Rinse with water. Get medical attention if irritation develops and persists.
<b>Ingestion</b>	Rinse mouth. If ingestion of a large amount does occur, call a poison control center immediately. Do not induce vomiting without advice from poison control center. If vomiting occurs, keep head low so that stomach content doesn't get into the lungs.
<b>Most important symptoms/effects, acute and delayed</b>	Cardiovascular effects. Pharmacologically active material. Occupational exposure may cause physiological effects.
<b>Indication of immediate medical attention and special treatment needed</b>	Provide general supportive measures and treat symptomatically. Treatment of beta-adrenergic blocker overdose may include the following: Do not induce vomiting. Maintain an open airway and assist ventilation if necessary. Administer activated charcoal as a slurry and perform gastric lavage to decrease absorption. Gastric lavage may increase vagal tone. Perform an early echocardiographic evaluation to expedite diagnosis and treatment of cardiac toxicity. For mild hypotension, administer intravenous fluids. For severe hypotension, administer intravenous glucagon, calcium, or catecholamines (dopamine, norepinephrine, epinephrine). Concurrent high-dose insulin euglycemia therapy may allow for a decrease in the dose of catecholamine. For bradycardia, administer intravenous atropine, glucagon, and isoproterenol. Cardiac pacing may also be needed. For bronchospasm, administer nebulized bronchodilators. Systemic corticosteroids may also be beneficial. For seizures administer intravenous diazepam or lorazepam. Muscle relaxants and artificial ventilation may also be required. For dysrhythmias and conduction defects, sodium bicarbonate may be helpful. For hypoglycemia, administer glucose or glucagon.
<b>General information</b>	Remove from exposure. Remove contaminated clothing. For treatment advice, seek guidance from an occupational health physician or other licensed health-care provider familiar with workplace chemical exposures. In the United States, the national poison control center phone number is 1-800-222-1222. If person is not breathing, give artificial respiration. If breathing is difficult, give oxygen if available. Persons developing serious hypersensitivity (anaphylactic) reactions must receive immediate medical attention.

### 5. Fire-fighting measures

<b>Precautions for safe handling</b>	As a general rule, when handling USP Reference Standards, avoid all contact and inhalation of dust, mists, and/or vapors associated with the material. Clean equipment and work surfaces with suitable detergent or solvent after use. After removing gloves, wash hands and other exposed skin thoroughly. Select and use containment devices and personal protective equipment based on a risk assessment of material potency and exposure potential.
