Treatment of beta-adrenergic blocker overdose may include the following: Do not induce vomiting. Maintain an open airway and assist ventilation if necessary. Administer activated charcoal as a slurry and perform gastric lavage to decrease absorption. Gastric lavage may increase vagal tone. Perform an early echocardiographic evaluation to expedite diagnosis and treatment of cardiac toxicity. For mild hypotension, administer intravenous fluids. For severe hypotension, administer intravenous glucagon, calcium, or catecholamines (dopamine, norepinephrine, epinephrine). Concurrent high-dose insulin euglycemia therapy may allow for a decrease in the dose of catecholamine. For bradycardia, administer intravenous atropine, glucagon, and isoproterenol. Cardiac pacing may also be needed. For bronchospasm, administer nebulized bronchodilators. Systemic corticosteroids may also be beneficial. For seizures administer intravenous diazepam or lorazepam. Muscle relaxants and artificial ventilation may also be required. For dysrhythmias and conduction defects, sodium bicarbonate may be helpful. For hypoglycemia, administer glucose or glucagon.

General information
