Monitor for hypotension, dysrhythmias, respiratory depression, and need for endotracheal intubation. Evaluate for hypoglycemia, electrolyte disturbances, hypoxia. For agitation, administer benzodiazepines. For tachycardia with hemodynamic compromise, esmolol may be useful. Monitor vital signs. Monitor cardiac function. Administer oxygen. Evaluate for hypoxia, acidosis, and electrolyte disorders.

General information

Remove from exposure. Remove contaminated clothing.
