### 4. First-aid measures

<b>Inhalation</b>	If breathing is difficult, remove to fresh air and keep at rest in a position comfortable for breathing. Oxygen or artificial respiration if needed. Select and use containment devices and personal protective equipment based on a risk assessment of material potency and exposure potential.
