4. First-aid measures

Inhalation	If breathing is difficult, remove to fresh air and keep at rest in a position comfortable for breathing. Oxygen or artificial respiration if needed. Do not use mouth-to-mouth method if the substance is inhaled. Induce artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. Call a physician if symptoms develop or persist.
Skin contact	Remove contaminated clothing immediately and wash skin with soap and water. In case of eczema or other skin disorders: Seek medical attention and take along these instructions. Get medical attention if irritation develops and persists. For minor skin contact, avoid spreading material on unaffected skin. Wash clothing separately before reuse.
Eye contact	Rinse with water. Get medical attention if irritation develops and persists.
Ingestion	If ingestion of a large amount does occur, call a poison control center immediately. Get medical attention if symptoms occur.
Most important symptoms/effects, acute and delayed	Pharmacologically active material. Occupational exposure may cause physiological effects.
Indication of immediate medical attention and special treatment needed	Provide general supportive measures and treat symptomatically. Treatment of cephalosporin overdose may include the following: Administer charcoal as a slurry. Evaluate patients for signs and symptoms of hypersensitivity. Anaphylaxis should be managed with establishment of a patent airway, epinephrine, and diphenhydramine. For seizures, administer diazepam or lorazepam. If seizures recur, consider phenobarbital or propofol. Monitor for hypotension, dysrhythmias, respiratory depression, and need for endotracheal intubation. Evaluate for hypoglycemia, electrolyte disturbances, and hypoxia. Monitor fluid and electrolyte status in patients with severe vomiting and/or diarrhea. Monitor for renal and hematologic abnormalities. For coagulopathies, vitamin K has been beneficial.
General information	Remove from exposure. Remove contaminated clothing. For treatment advice, seek guidance from an occupational health physician or other licensed health-care provider familiar with workplace chemical exposures. In the United States, the national poison control center phone number is 1-800-222-1222. If person is not breathing, give artificial respiration. If breathing is difficult, give oxygen if available. Persons developing serious hypersensitivity (anaphylactic) reactions must receive immediate medical attention.

6. Accidental release measures

Personal precautions, protective equipment and emergency procedures	Keep unnecessary personnel away. Wear appropriate personal protective equipment. Avoid inhalation of dust from the spilled material. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ensure adequate ventilation. For personal protection, see section 8 of the SDS.
Methods and materials for containment and cleaning up	Avoid the generation of dusts during clean-up. Sweep up or vacuum up spillage and collect in suitable container for disposal. Clean surface thoroughly to remove residual contamination. For waste disposal, see section 13 of the SDS.

Environmental precautions Avoid discharge into drains, water courses or onto the ground.

7. Handling and storage

Precautions for safe handling As a general rule, when handling USP Reference Standards, avoid all contact and inhalation of dust, mists, and/or vapors associated with the material. Clean equipment and work surfaces with suitable detergent or solvent after use. After removing gloves, wash hands and other exposed skin thoroughly. Select and use containment devices and personal protective equipment based on a risk assessment of material potency and exposure potential.

Conditions for safe storage, including any incompatibilities Store in tight container as defined in the USP-NF. This material should be handled and stored per label instructions to ensure product integrity.

Other Train employees in proper gowning and degowning practices. Wear lab coat. Base the choice of skin protection on the job activity, potential for skin contact and solvents and reagents in use. Do not wear protective garments in common areas (e.g., cafeterias) or out-of-doors.

Respiratory protection Respirators are generally not required for laboratory operations. Use a tight-fitting full-face respirator with HEPA filters for spill cleanup. Choose respiratory protection appropriate to the task and the level of existing engineering controls.
