### 4. First-aid measures

<b>Inhalation</b>	If breathing is difficult, remove to fresh air and keep at rest in a position comfortable for breathing. Oxygen or artificial respiration if needed. Induce artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. If experiencing respiratory symptoms: Call a poison center or doctor/physician.
<b>Skin contact</b>	Rinse skin with water/shower. In case of eczema or other skin disorders: Seek medical attention and take along these instructions. Get medical attention if irritation develops and persists. Wash clothing separately before reuse.

<b>Most important symptoms/effects, acute and delayed</b>	Pharmacologically active material. Occupational exposure may cause physiological effects.
<b>Indication of immediate medical attention and special treatment needed</b>	Provide general supportive measures and treat symptomatically. Treatment of cephalosporin overdose may include the following: Administer charcoal as a slurry. Evaluate patients for signs and symptoms of hypersensitivity. Anaphylaxis should be managed with establishment of a patent airway, epinephrine, and diphenhydramine. For seizures, administer diazepam or lorazepam. If seizures recur, consider phenobarbital or propofol. Monitor for hypotension, dysrhythmias, respiratory depression, and need for endotracheal intubation. Evaluate for hypoglycemia, electrolyte disturbances, and hypoxia. Monitor fluid and electrolyte status in patients with severe vomiting and/or diarrhea. Monitor for renal and hematologic abnormalities. For coagulopathies, vitamin K has been beneficial.
<b>General information</b>	Remove from exposure. Remove contaminated clothing. For treatment advice, seek guidance from an occupational health physician or other licensed health-care provider familiar with workplace chemical exposures. In the United States, the national poison control center phone number is 1-800-222-1222. If person is not breathing, give artificial respiration. If breathing is difficult, give oxygen if available. Persons developing serious hypersensitivity (anaphylactic) reactions must receive immediate medical attention.

### 5. Fire-fighting measures

## 7. Handling and storage

**Precautions for safe handling** As a general rule, when handling USP materials, avoid all contact and inhalation of dust, mists, and/or vapors associated with the material. Clean equipment and work surfaces with suitable detergent or solvent after use. After removing gloves, wash hands and other exposed skin thoroughly. Select and use containment devices and personal protective equipment based on a risk assessment of material potency and exposure potential.

**Conditions for safe storage, including any incompatibilities** Store in tight container. This material should be handled and stored per label instructions to ensure product integrity.
