### 4. First-aid measures

<b>Inhalation</b>	If breathing is difficult, remove to fresh air and keep at rest in a position comfortable for breathing. Do not use mouth-to-mouth method if the substance is inhaled. Oxygen or artificial respiration if needed. If experiencing respiratory symptoms: Call a POISON CENTER or doctor/physician.

<b>Most important symptoms/effects, acute and delayed</b>	Pharmaceutical related compound of unknown potency. It is not known if occupational exposure may cause physiological effects.
<b>Indication of immediate medical attention and special treatment needed</b>	Provide general supportive measures and treat symptomatically. Treatment of cephalosporin overdose may include the following: Administer activated charcoal as a slurry. For acute hypersensitivity, administer epinephrine and diphenhydramine. Treat seizures with a benzodiazepine IV or barbiturates if needed. Monitor fluid and electrolyte status; for hematologic and renal abnormalities; for hypotension; and for respiratory depression. For coagulopathies, administer Vitamin K.
<b>General information</b>	Remove from exposure. Remove contaminated clothing. For treatment advice, seek guidance from an occupational health physician or other licensed health-care provider familiar with workplace chemical exposures. In the United States, the national poison control center phone number is 1-800-222-1222. If person is not breathing, give artificial respiration. If breathing is difficult, give oxygen if available. Persons developing serious hypersensitivity (anaphylactic) reactions must receive immediate medical attention.
