Obtain a baseline CBC and ABG (or venous blood gas), and monitor patient closely. Administer vitamins B6 and B12 for neuritis. For hypothermia, rewarm slowly using blankets, warm IV fluids, and/or warmed mist inhalation. Manage anaphylaxis by conventional symptomatic and supportive measures. For toxic bone marrow effects, L-phenylalanine has been administered experimentally. To remove chloramphenicol from plasma, use charcoal hemoperfusion. Hemodialysis is not effective in removing chloramphenicol.
General information	Remove from exposure. Remove contaminated clothing. For treatment advice, seek guidance from an occupational health physician or other licensed health-care provider familiar with workplace chemical exposures. In the United States, the national poison control center phone number is 1-800-222-1222. If person is not breathing, give artificial respiration. If breathing is difficult, give oxygen if available. Persons developing serious hypersensitivity (anaphylactic) reactions must receive immediate medical attention.
