4. First-aid measures

Inhalation If breathing is difficult, remove to fresh air and keep at rest in a position comfortable for breathing.

Provide general supportive measures and treat symptomatically. Do not induce vomiting. Administer activated charcoal as a slurry. Monitor vital signs. Provide assisted ventilation. For hypotension, infuse 10- 20 mL/kg isotonic fluid. Administer dopamine or norepinephrine if hypotension persists. Flumazenil, a benzodiazepine agonist/antagonist, has been administered intravenously to reverse coma and respiratory depression in cases of severe poisoning.

Flumazenil use is not recommended in cases where seizures are likely or there is serious cyclic antidepressant poisoning. Forced diuresis is not effective. Hemodialysis is unlikely to be of benefit. Manage withdrawal symptoms initially with phenobarbital or the benzodiazepine, then decrease

dose by about 10% per day for ten days.

General information Remove from exposure. Remove contaminated clothing. For treatment advice, seek guidance from

7. Handling and storage
