4. First-aid measures

Central nervous system depression. Pharmaceutical related compound of unknown potency. It is not known if occupational exposure may cause physiological effects.

Indication of immediate medical attention and special treatment needed

Provide general supportive measures and treat symptomatically. Do not induce vomiting. Administer activated charcoal as a slurry. Monitor vital signs. Protect airway and support ventilation and perfusion. For hypotension, infuse 10- 20 mL/kg isotonic fluid. Administer dopamine or norepinephrine if hypotension persists. Flumazenil, a benzodiazepine agonist/antagonist, has been administered intravenously to reverse coma and respiratory depression in cases of severe poisoning. Flumazenil use is not recommended in cases where seizures are likely or there is serious cyclic antidepressant poisoning. Forced diuresis is not effective. Hemodialysis is unlikely to be of benefit. Manage withdrawal symptoms initially with phenobarbital or the benzodiazepine, then decrease dose by about 10% per day for ten days.

General information

Remove from exposure. Remove contaminated clothing. For treatment advice, seek guidance from an occupational health physician or other licensed health-care provider familiar with workplace chemical exposures. In the United States, the national poison control center phone number is 1-800-222-1222. If person is not breathing, give artificial respiration. If breathing is difficult, give oxygen if available. Persons developing serious hypersensitivity (anaphylactic) reactions must receive immediate medical attention.
