4. First-aid measures

Inhalation If breathing is difficult, remove to fresh air and keep at rest in a position comfortable for breathing. Call a physician if symptoms develop or persist.

Skin contact Rinse skin with water/shower. Get medical attention if irritation develops and persists.

Eye contact Call a physician or poison control center immediately. Rinse with water. Remove contact lenses, if present and easy to do. Continue rinsing.

Ingestion Rinse mouth. If ingestion of a large amount does occur, call a poison control center immediately. Do not induce vomiting without advice from poison control center.

General information Remove from exposure. Remove contaminated clothing. 5. Fire-fighting measures

Suitable extinguishing media Water. Foam. Dry chemical or CO₂. Use fire-extinguishing media appropriate for surrounding materials.

Specific hazards arising from the chemical Explosion hazard: Avoid generating dust; fine dust dispersed in air in sufficient concentrations and in the presence of an ignition source is a potential dust explosion hazard.

Special protective equipment and precautions for firefighters Wear suitable protective equipment.

Fire fighting equipment/instructions Use water spray to cool unopened containers. As with all fires, evacuate personnel to a safe area. Firefighters should use self-contained breathing equipment and protective clothing.

Specific methods Use standard firefighting procedures and consider the hazards of other involved materials.

6. Accidental release measures

Personal precautions, protective equipment and emergency procedures Keep unnecessary personnel away. Dust deposits should not be allowed to accumulate on surfaces, as these may form an explosive mixture if they are released into the atmosphere in sufficient concentration. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Avoid inhalation of dust from the spilled material. Ensure adequate ventilation. Wear appropriate personal protective equipment. For personal protection, see section 8 of the SDS.

Methods and materials for containment and cleaning up For waste disposal, see section 13 of the SDS. Avoid the generation of dusts during clean-up. Sweep up or vacuum up spillage and collect in suitable container for disposal. Clean surface thoroughly to remove residual contamination.

Environmental precautions Avoid discharge into drains, water courses or onto the ground.

7. Handling and storage

Precautions for safe handling

As a general rule, when handling USP materials, avoid all contact and inhalation of dust, mists, and/or vapors associated with the material. Clean equipment and work surfaces with suitable detergent or solvent after use. After removing gloves, wash hands and other exposed skin thoroughly. Avoid significant deposits of material, especially on horizontal surfaces, which may become airborne and form combustible dust clouds and may contribute to secondary explosions. Combustible dust clouds may be created where operations produce fine material (dust). Select and use containment devices and personal protective equipment based on a risk assessment of material potency and exposure potential.

Conditions for safe storage, including any incompatibilities

Store in tight container. This material should be handled and stored per label instructions to ensure product integrity.
