6. Accidental release measures

Personal precautions, protective equipment and emergency procedures

Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ensure adequate ventilation. For personal protection, see section 8 of the SDS.

Use water spray to cool unopened containers. As with all fires, evacuate personnel to a safe area.

7. Handling and storage
