### 4. First-aid measures

<b>Inhalation</b>	If breathing is difficult, remove to fresh air and keep at rest in a position comfortable for breathing. Call a physician if symptoms develop or persist.

<b>Indication of immediate medical attention and special treatment needed</b>	Provide general supportive measures and treat symptomatically. Treatment for overdose should include the following: Administer activated charcoal or gastric lavage where appropriate. For hypotension, administer intravenous fluids and place patient in a supine position. For respiratory arrest, intubate and supply mechanical ventilation. Flumazenil may reverse sedation. Do NOT use in patients with cardiac arrhythmias or seizure disorders.
<b>General information</b>	Remove from exposure. Remove contaminated clothing.
