#### 4. First-aid measures

#### 5. Fire-fighting measures

<b>Precautions for safe handling</b>	As a general rule, when handling USP Reference Standards, avoid all contact and inhalation of dust, mists, and/or vapors associated with the material. Select and use containment devices and personal protective equipment based on a risk assessment of material potency and exposure potential.
