4. First-aid measures

Inhalation	If breathing is difficult, remove to fresh air and keep at rest in a position comfortable for breathing. Call a physician if symptoms develop or persist.

General information	Remove from exposure. Remove contaminated clothing. In the United States, the national poison control center phone number is 1-800-222-1222. If person is not breathing, give artificial respiration. If breathing is difficult, give oxygen if available. Persons developing serious hypersensitivity (anaphylactic) reactions must receive immediate medical attention.

Precautions for safe handling	As a general rule, when handling USP materials, avoid all contact and inhalation of dust, mists, and/or vapors associated with the material.
