### 4. First-aid measures

<b>Inhalation</b>	If breathing is difficult, remove to fresh air and keep at rest in a position comfortable for breathing. Do not use mouth-to-mouth method if the substance is inhaled. Induce artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. Call a physician if symptoms develop or persist.
<b>Skin contact</b>	Wash off with soap and water. Get medical attention if irritation develops and persists.
<b>Eye contact</b>	Rinse with water. Get medical attention if irritation develops and persists.
<b>Ingestion</b>	Rinse mouth. If ingestion of a large amount does occur, call a poison control center immediately. Do not use mouth-to-mouth method if substance is ingested. If vomiting occurs, keep head low so that stomach content doesn't get into the lungs. Induce artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device.
<b>Most important symptoms/effects, acute and delayed</b>	Narcotic effects. Pharmacologically active material. Occupational exposure may cause physiological effects.
<b>Indication of immediate medical attention and special treatment needed</b>	Provide general supportive measures and treat symptomatically. Administer activated charcoal as a slurry. Perform gastric lavage. Protect airway and support ventilation and perfusion. For hypotension, infuse 10- 20 mL/kg isotonic fluid. Administer dopamine or norepinephrine if hypotension persists. For bradycardia, administer atropine intravenously. For seizures, administer intravenous diazepam or lorazepam. If seizures recur, administer phenobarbital or propofol. Monitor for hypotension, dysrhythmias, respiratory depression, and need for endotracheal intubation. Evaluate for hypoglycemia, electrolyte disturbances, and hypoxia. For rhabdomyolysis, administer saline or diuretics to maintain urine output. Urinary alkalization is NOT recommended. For ventricular arrhythmia, obtain ECG, institute continuous cardiac monitoring, and administer oxygen. Evaluate for hypoxia, acidosis, and electrolyte disorders. For stable monomorphic ventricular tachycardia, administer lidocaine and amiodarone. For unstable rhythms, immediate cardioversion is required
<b>General information</b>	Remove from exposure. Remove contaminated clothing. For treatment advice, seek guidance from an occupational health physician or other licensed health-care provider familiar with workplace chemical exposures. In the United States, the national poison control center phone number is 1-800-222-1222. If person is not breathing, give artificial respiration. If breathing is difficult, give oxygen if available. Persons developing serious hypersensitivity (anaphylactic) reactions must receive immediate medical attention.

**7. Handling and storage****Precautions for safe handling**

As a general rule, when handling USP Reference Standards, avoid all contact and inhalation of dust, mists, and/or vapors associated with the material. Clean equipment and work surfaces with suitable detergent or solvent after use. After removing gloves, wash hands and other exposed skin thoroughly. Avoid significant deposits of material, especially on horizontal surfaces, which may become airborne and form combustible dust clouds and may contribute to secondary explosions. Combustible dust clouds may be created where operations produce fine material (dust). Select and use containment devices and personal protective equipment based on a risk assessment of material potency and exposure potential.
