The therapeutic use of ACE inhibitors during the second and third trimesters of pregnancy has been associated with serious fetal and newborn injury, including growth retardation, renal impairment, oligohydramnios, hypocalvaria, fetal pulmonary hypoplasia, reduced fetal blood pressure, newborn anuria, patent ductus steriosus, and death. Prematurity can also occur. ACE inhibitors have demonstrated little or no teratogenicity in animal studies.
