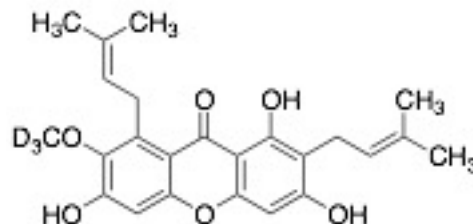

### Appropriate Engineering Controls
