

General Advice

4.2 Most Important Symptoms and Effects, Both Acute and Delayed

Sleepiness, weight gain, mild temporary increase in serum prolactin, dizziness, weakness, restlessness, increased appetite, swelling of hands and feet, decreased blood pressure when standing, dry mouth and constipation. Mild temporary increases in glucose and liver enzyme levels and blood effects have been seen occasionally. Symptoms reported in olanzapine overdose include changes in heart rate and rhythm, slurred speech, reduced level of consciousness ranging from sedation to coma, convulsion, and muscle rigidity.

Appropriate Engineering Controls

Eye/Face Protection

Skin Protection

Gloves used for incidental exposures (splash protection) should be designated as "chemical resistant" by EU standard EN 374 with the resistance codes corresponding to the anticipated use of the material. Unrated gloves are not recommended. Suggested gloves: AnsellPro Sol-Vex nitrile gloves style 37-175, 15 mil thickness. Penetration time has not been determined.

Gloves used for prolonged direct exposure (immersion) should be designated "chemical resistant" as per EN 734 with the resistance codes corresponding to the anticipated use of the material.

Suggested gloves: AnsellPro Viton/Butyl gloves style 38-612, 4/8 mil thickness.
